AGREEMENT AND RELEASE FROM LIABILITY

1. Assumption of Risk. I am aware that there is a risk of damage to or loss of my works of art at the Clark Center. I understand that the works of art which I display are exposed to the public on numerous occasions, and are unattended on many other occasions, and at no time are the works of art guarded. I also understand that the lobby exhibit space has exposure to sunlight and is not always temperature controlled. As consideration for being permitted to place my works of art in the Clark Center for public display, potential sale and promotional purposes, I hereby agree that I, my assignees, heirs, distributees, guardians, and legal representatives will not make a claim against, sue, or attach the property of the Clark Center for the Performing Arts, Inc.; or the Lucia Mar Unified School District; or any officer, director, employee, contractor, agent, or representative of any of them, on account of any loss or damage resulting from the negligence or other acts, howsoever caused, or failure to act, by any employee, agent, or contractor of any of them, or by any member of the public, as a result of my placing said works of art at the Clark Center. I hereby release the Clark Center for the Performing Arts, Inc.; the Lucia Mar Unified School District; and all officers, directors, employees, contractors, agents, or representatives of any of them from all actions, claims, or demands that I, my assignees, heirs, distributors, guardians, and legal representatives now have or may hereafter have for injury, damage or loss resulting from my placing said works of art at the Clark Center, as attested by my initials here: \_\_\_\_\_.
